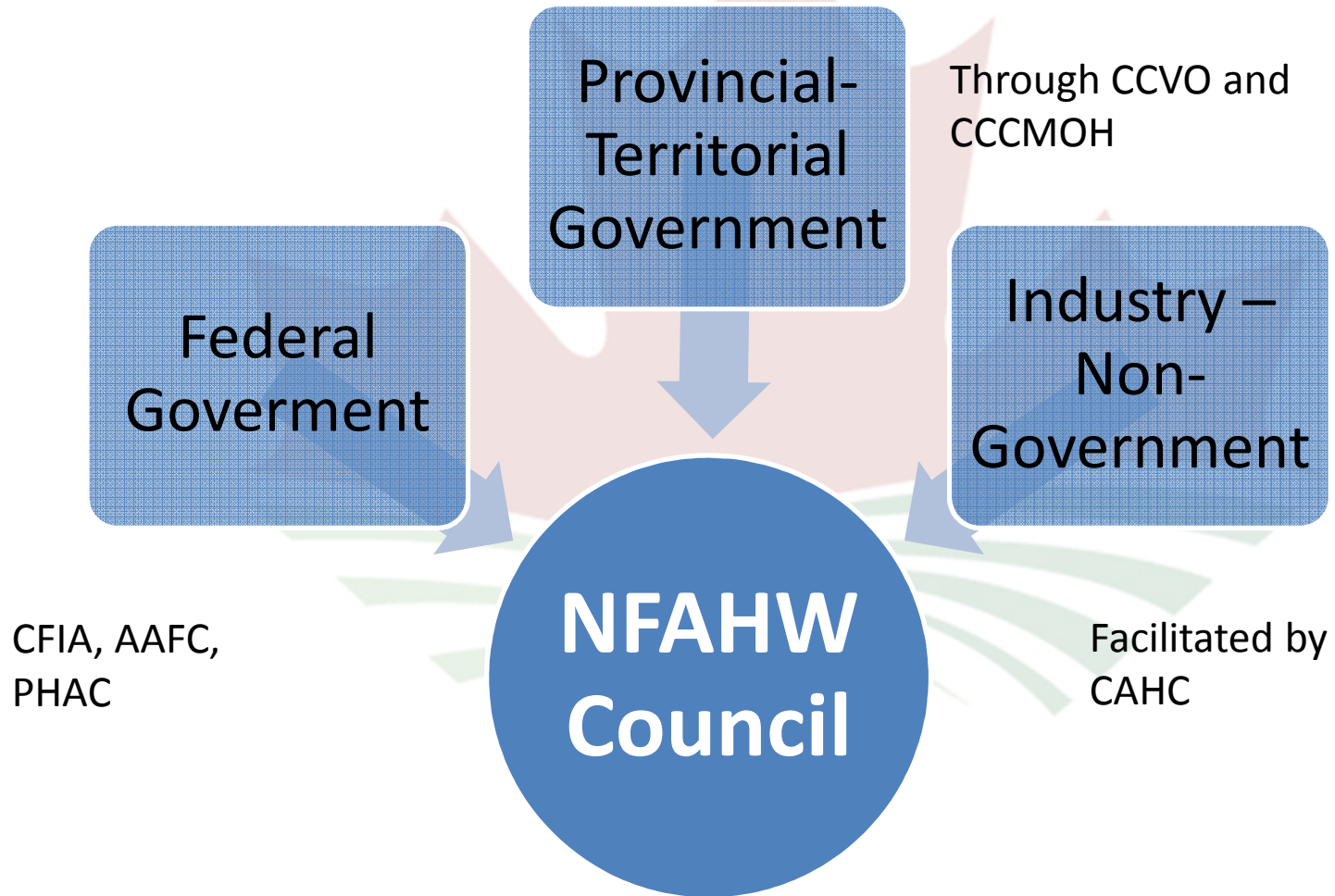

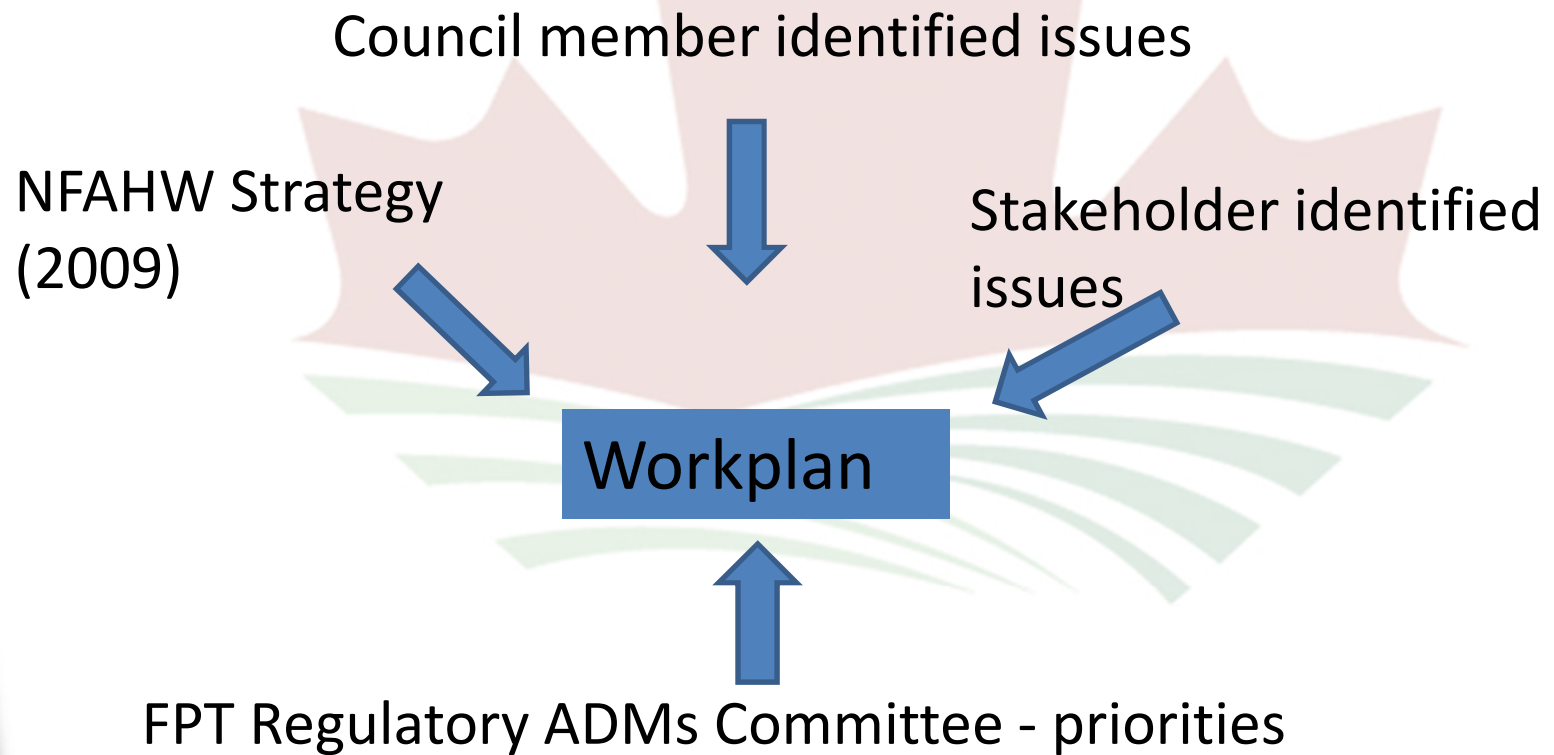



- Studying how to approach
- Forum presentations about three activities which may impact emerging issues management
